- The Fire Prevention Division is seeing an over-flow of Plan Review. Main Situation is the Eastlake High School project. Completion is set by the start of next school year.
- The Fire Prevention Division summary for the up-coming web site has been completed. Pending Items to add to web-site: (1) Q & A's (Frequently asked questions); (2) Employee profile; (3) Attach links; (4) Attach forms
- Fire Marshal will be requesting a Deputy Fire Marshal for assistance in the
 future. He will choose from the two (2) Texas Certified Fire Inspectors
 working for Horizon City Fire Department. This future position for Deputy Fire
 Marshal will assist, when Fire Marshal is not available due to vacation,
 sickness, or over-loaded with administrative duties, inspections and reinspections.
- Continue meeting with EPFD and ESD and several fire contractors to discuss changes within each jurisdiction. Our "ultimate goal" is to be consistent throughout the County of El Paso.
- Advised Horizon City Code Enforcement and the Building Official of E.P.C. E.S.D. #1 adopting new Fire Code.
- Continue meeting with members of the Horizon City Fire Department during Training Week (Wednesday) to disseminated information and listen to any concern the HCFD may have or need to address.
- Consulting with numerous general contractors about up-coming construction. (Taco Bell; Fire Alarm for Wal-Mart; Fire Alarm for HCFD; Fire Alarm For Dreams; Residential Sub-divisions; New Construction Sites; Eastlake High School; a new S.I.S.D. school within the E.P.C. E.S.D. #1's jurisdiction.
- Working with Chief Roger Esparza and Robert Grijalva (Assistant to Chinte Quintanilla's – State Rep) in investigating the Illegal Disposal of Scrap Tires within the County of El Paso. Several illegal sites. The El Paso County Attorney's Office is fully supporting project.
- Creating a new Resolution to adopt the new "Fire Lane" Policy. Accepting
 this policy will keep the El Paso County E.S.D. #1 consistent with the City of
 El Paso Fire Department and The El Paso County E.S.D. #2
 - 11. Motion to accept Fire Marshal's report made by Commissioner Hambric and seconded by Commissioner Ames. Motion carried unanimously.

- 12. Motion made by Commissioner McLellan to table fire lane policy. Motion seconded by Commissioner Gelasco. Item tabled.
- 13. Motion to allow \$2006.50 to send Fire Marshal to the Firehouse software training in September. Motion made by Commissioner Ames and seconded by Commissioner Hambric. Motion carried unanimously.
- 14. Motion to table made by Commissioner Shoppach and seconded by Commissioner Ames. Item tabled.
- 15. We are going to have to set the Fire Marshal's office up as a separate entity if he is going to get certified as "Head of Department" with TCFP. This will be necessary if he is to supervise other inspectors. (See item #16). Motion to write letter separating offices made by Commissioner Hambric and seconded by Commissioner Ames. Motion carried unanimously.
- 16. Discussion on part time Deputy Fire Marshal(s) due to increasing volume of inspections and plans reviews coming into the office. Commissioner McLellan also discussed the growth and plans for the area around Eastlake and Rojas intersection and also around the Socorro Sports Complex.
- 17. Motion to delete forms made by Commissioner Hambric and seconded by Commissioner Ames. Item deleted.
- 18. The City of El Paso still has not written our \$25000 check for the annexation. There is another hearing on May 5 that Richard will be presenting summary briefs on our behalf. Motion by Commissioner McLellan to have Richard proceed. Motion seconded by Commissioner Hambric. Motion carried unanimously.
- 19-20 Richard brought in copies of maps showing our boundaries. Now we need to define precincts. Motion to table made by Commissioner Ames and seconded by Commissioner McLellan. Item tabled.
- 21. Commissioner Hambric presented information on the Legislative Breakfast that he and Commissioner Gelasco attended. They met with Representative Picket who stated that if he went against the bill it would be "5 against 1 and pointless". Richard met with Judge Escobar and Attorney Lee Shapleigh last Tuesday. Richard stated that they had a productive meeting and that he asked the Judge for more direction on what she wants from us. She stated that they would not be "micro-managing" us, but that they would be looking at our budget and approving it along with the tax rate. She stated that after the bill passes she intends to have a meeting with the ESD#1 Commissioners, the ESD#2 Commissioners and the County Commissioners. She did apologize for not speaking to the ESD Commissioners before proceeding with this bill. Motion to table made by Commissioner Hambric and seconded by Commissioner Gelasco. Item tabled.
- 22. We have one change order for the new station from Blair-Hall. The metal originally specified is not readily available. They showed us a sample of another metal that is a little darker in color, thicker material wise and has a zinc coating for fade resistance. The cost of the material is \$5000. Imetco, the distributor for this product has been in negotiations with Hector from BRW about this. They are willing to split the cost with us to showcase this newer product and give us an additional 5 years of warranty bring it up to 25 years. Commissioner Hambric

- made a motion that we table this until we get further information. Motion seconded by Commissioner McLellan. Item tabled.
- 23. Motion to delete surplus equipment made by Commissioner Hambric and seconded by Commissioner Gelasco. Item deleted.
- 24. Motion made by Commissioner Shoppach to accept the Investment policy as presented by Commissioner Ames. Item seconded by commissioner Gelasco. Motion carried unanimously.
- 25. Motion to delete FRO made by Commissioner Hambric and seconded by Commissioner Ames. Item deleted.
- 26. We received two bids for the technology portion of the new station (phones, keys, cameras and internet). Bid #1 was from Matrix for \$89000. This bid was for analog instead of digital phones. We asked Matrix for an additional quote for the difference in price between the analog and digital phones for this meeting but never received one. There was no back-up documentation with the bid showing brand quoted, specifications or technical information. Of the references supplied by Matrix, only one called back and he stated that they only serviced his extinguishers. Bid #2 was from AST for \$139,000. This was a very complete and professional bid. It included references, technical information, specifications and even brochures showing the different phones quoted. The references supplied all gave excellent recommendations about this company. The references also stated that this company has service technicians available on the weekends and nights which is very important to us. Motion made by Commissioner McLellan to award bid to AST. Motion seconded by Commissioner Gelasco. Motion carried unanimously.
- 27. Motion made by Commissioner McLellan to approve the design for the new ESD badges. Motion seconded by Commissioner Shoppach. Motion carried unanimously.
- 28. No Executive Session needed.
- 29. For The Good of The District: Commissioners will start working on some type of presentation to take to the County Commissioners possibly in May. It will show station progress, call volume etc. Commissioner Gelasco said he would like to see some kind of a brochure or newsletter be put together at the end of the year showing what we have done for the district.
