Minutes of the March 25, 2021 Commissioners Meeting

1. Call to order: Meeting called to order at 6:30 pm

2. Establishment of a quorum: Commissioners present in building: Commissioner Mayberry, Commissioner Rankins, Commissioner Anaya and Commissioner Booth. Attending virtual: Commissioner Berumen

3. Pledge of Allegiance: The Pledge was recited.

4. Presentations: None

5. Review and approve minutes of February 25, 2021 meeting: Motion to approve minutes as presented made by Commissioner Anaya and seconded by Commissioner Rankins. Motion carries.

6. Election Matters:

Review and take action on the following matters and Orders relating to conduct an election on the adoption of a sales and use tax in the District under Health and Safety Code §§ 775.0751 and 775.0752:

- a. Action to approve a contract with the El Paso County Elections office for services relating to the conduct of the election.
- b. To Consider and take action on such other Orders, Resolutions and related matters as required or appropriate to call for District sales tax Election on May 1, 2021 on the Proposition of allowing the adoption of a District sales and use tax.
- c. Determine the canvassing date for the May 1, 2021 election.

Sonya Aston from Coveler and Peeler presented the contract from the Elections office. Commissioner Rankins asked where Exhibit A was that was mentioned in the contract. Mrs. Aston reported that this had been presented at a previous meeting and Fiscal Administrator Ames will provide a copy of this to the board. Motion to approve the contract as presented made by Commissioner Anaya and seconded by Commissioner Rankins. Motion carries. Motion to table 6b and 6c made by Commissioner Berumen and seconded by Commissioner Rankins. Motion carries.

7. **Discussion of update on Community Education Program:** Wendy Duncan from Touchstone District Services provided an update on the election. The website is up and functioning and she encourages all to share events on Social media and make a 7-word comment. We are also paying for Facebook ads to spread our message to a larger population.

Fiscal Administrator Ames stated that we need some help at the Early polling places, and you can sign up with her. Agenda item was for discussion only. No action taken.

- 9. Review and approve Chief's report on run volume, stipend, training, fleet, personnel, fire response, building construction and additional fire information: (Report given by Chief Menendez)
 - Calls for the month of February : 318
 - Station 1 Calls: 207 Station 2 Calls: 111
 - Calls for the year 2021: <u>641</u>
 - Stipend: \$49,477.74 (Two periods)
 - **Hours:** 4,036.50
 - **FMO:** Two polices have been created and are on the agenda for review. Operations will be attending a walk through on the 31st of March at Amazon.
 - **Training**: TEEX conducted a Haz Mat awareness and Operations course. We had 22 students in the class. We will be training on the new SCOTTS that arrived the second week of April.
 - CoVID 19:. No one currently out on CoVID
 - **Fleet**: Rescue 403 almost complete with lighting. Rescue 405 repairs are complete. Unit was picked up today.
 - **Personnel**: Interviewed 8 potential candidates on Wednesday. All 8 were accepted and will start in April.
 - **Fire Response:** Six total call outs for Structure fires. Two were working fires that involved fireplaces.
 - **Building Construction:** Warranty work still be performed at station 2. Wrapping items up, only have one or two items left. Shower completed at Station 2 that was leaking. No issues to report, covered under warranty.
 - Misc.: Multiple call outs for Special Operations response. First was a male that fell into a hole at Red Sands. C*SAR team was activated, male was assisted by bystanders in the area and was taken to the hospital before units could locate. Second was a male who had injuries from an assault, C*SAR team was activated, male was located by father and

taken to the hospital prior to team locating. Drone Call out accord at the same time, once the initial incident was cleared drone was no longer needed. Request was for a male who fled an MVA and was in the desert area. Responded to a Confined Space where a male fell into a manhole approximately 25 ft. El Paso Fire assisted Horizon crews. CH 401 made entry and rescued the male out of the hole. He had sustained minor injuries. There was a total of 8 rope techs on the scene, assisting with incident. Lastly Drone call out for missing juvenile in the desert area. Drone was flown for 1.5 hours, negative contact made. Save a pet decals have been created a memo on how and where to place these stickers will follow.

Commissioner Mayberry asked questions about the mobile air and how it is utilized. The Chief gave more of an explanation of how it is used on scene and the capacity abilities. Motion to accept Chief's report made by Commissioner Rankins and seconded by Commissioner Berumen. Motion carries.

Commissioner Berumen asked what percentage has the workload increased? Fire Marshal Guillen stated he did not have a percentage but that the workload has increased significantly. Commissioner Berumen also asked about the workspace capacity. Mr. Guillen said that they are making do with what they have but some days it can be difficult, but that additional staff will be needed in the new budget. Chief Menendez stated that additional staff will be considered when budgeting for the next Fiscal Year along with the ESD building. Motion to approve the report as presented made by Commissioner Anaya and seconded by Commissioner Booth. Motion carries.

- 11. Discussion and take action on Surplus equipment: Chief Menendez presented the surplus form with a shed, toolbox and Fire hose. He is asking the board to surplus all the items. The shed and toolbox will be sold by blind auction internally and the Fire hose will be donated to organizations for non-firefighting use. Motion to approve made by Commissioner Anaya and seconded by Commissioner Booth. Motion carries.
- 12. Discussion and take action on Policy to reduce cost of FMO fees for churches and Municipalities: Chief Menendez presented the Policy as drafted by our attorney based on a similar policy that Town of Horizon has. There were some changes made to the minimum project cost amount for reduction and number of days to submit request prior to BOC meeting. There was a question about how this would affect a prior legal agreement with a local School District. Which Attorney Sanchez stated this would not impact that agreement. Commissioner Booth asked about criteria for the board to determine the percentage of reduction of fees. Attorney Sanchez stated that would be more of internal guidelines and should not be a part of the policy. More discussion took place on the policy. Motion to approve the policy as written made by Commissioner Anaya and seconded by Commissioner Rankins. Motion carries.
- 13. Discussion and take action on purchase of new property: Michael Livingston signed up to make a public comment on this agenda item. He provided maps of two portions of land that is for sale on Kenazo. It is currently \$12.00 per square foot and is PUD land. The price can be negotiated especially if it is made in a bulk purchase. The property has onsite utilities, and the depth of the lot is 350 square feet deep from Kenazo for both pieces of property. Both properties are also considered raw land meaning it needs to be cleared

off before it can be graded. The Chief will ask legal about zoning of the land. Chief Menendez also spoke that the land presented at a previous meeting and the similarities and difference in them. Motion to table made by Commissioner Booth and seconded by Commissioner Rankins. Motion carries.

- **14. Discussion and take action on Purchase of Bunker Gear:** Chief Menendez presented a quote to purchase 6 sets of gear in the amount of \$18,576.00 from account 9500.01. Motion to approve the quote made by Commissioner Berumen and seconded by Commissioner Rankins. Motion carries.
- 15. Discussion and take action on purchase of Fire Equipment: Chief Menendez presented 2 quotes for Fire Equipment. The first quote was from Witmer Public Service Group for 11 sets of boots in the amount of \$6,828.88 from account 9100.02. Motion to approve made by Commissioner Rankins and seconded by Commissioner Anaya. Motion carries. Second quote is from W.S. Darley for replacement scene lighting for Q-401 in the amount of \$4,618.00 from account 9300.02. This will be installed by us. Motion to approve made by Commissioner Booth and seconded by Commissioner Rankins. Motion carries.

- **16. For the Good of the District:** Chief Menendez reported that the Fire Fighters will be walking the blocks in our District four Saturday's leading up to the election.
