

RESOLUTION NO. 2023-002

A RESOLUTION OF THE BOARD OF COMMISSIONERS FOR THE EL PASO COUNTY EMERGENCY SERVICES DISTRICT No. 1, EL PASO COUNTY, TEXAS, SETTING THE PROPERTY TAX RATE FOR THE TAXABLE YEAR COMMENCING OCTOBER 1, 2023 AND ENDING SEPTEMBER 30, 2024

WHEREAS, the El Paso County Emergency Services District No. 1 (the “District”) is an emergency services district and political subdivision created under Chapter 775 of the Texas Health and Safety Code; and

WHEREAS, the District gave notice of the date, time, and place of the meeting at which it would consider and vote on the District’s tax rate in accordance with all applicable laws and regulations and, after meeting all requirements for consideration and adoption of a tax rate, the District’s Board of Commissioners did hold such meeting on August 16, 2023, to vote on the tax rate; and

WHEREAS, on August 16, 2023, the District’s Board of Commissioners adopted a tax rate for the fiscal year commencing October 1, 2023, and ending September 30, 2024, at the rate of 0.100000 per \$100.00 of property value, consisting of an Interest and Sinking tax rate of 0.047326 and a Maintenance and Operations tax rate of 0.052674; and

WHEREAS, it was, and is, in the public interest and welfare to adopt such tax rate for the purpose of carrying out the purposes, objectives, maintenance, and operations of the District.


NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the El Paso County Emergency Services District No. 1 as follows:

On this date, the Board of Commissioners for and on behalf of the El Paso County Emergency Services District No. 1, does hereby set the property tax rate for the fiscal year commencing October 1, 2023 and ending September 30, 2024, at the rate of 0.100000 per \$100.00 of property value, consisting of an Interest and Sinking tax rate of 0.047326 and a Maintenance and Operations tax rate of 0.052674.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR’S TAX RATE.


THE TAX RATE WILL EFFECTIVELY BE RAISED BY 17.47 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$8.47.
