**** Pyrotechnic Special Effects Including Fireworks and Fire Performers:**

Application Instructions (Your application packet should include):

- This application shall be filled out entirely; too include the appropriate fee and payment type.
- Application must be accompanied by the following:
 - A description of the display or show, including a list of the type and number of pyrotechnic effects.
 - A plot plan of the display area showing the location of discharge; fall-out zone; & the audience area
 - Attach map-showing area, in which fireworks will be detonated, all buildings within six hundred (600) feet of such area, area to be used by spectators, and place of storage of fireworks before and during display.
- Attach copy of surety bond, or certificate of insurance.
- All vehicles transporting pyrotechnics must comply with 49 CFR Chapter 1(F).
- All Company/licensee's business information. A copy of your Texas State License to perform a display shall be attached to your application.
- Additional permits from Federal, State, or other authorities may be required.
- The FM may require a demonstration of any pyrotechnic, firework, or fire performance prior to final approval.
- Attach photocopy of pyrotechnic operator's license.

Fireworks public display permits must be obtained from the State Board of Insurance through the State Fire Marshal. A public firework display permit is not renewable and is valid for only one public firework display to be held during the hours and on the date or alternate date, if provided, stated on the permit. Public Displays: An adult individual or firm, partnership, corporation, or association planning to make a public fireworks display shall submit, under rules adopted by the board, a written application to the State Fire Marshal for a license or permit. It is the duty of the designated local Fire Marshal (FM) or designee, to make a site inspection to determine whether a proposed fireworks display is in a location that may be hazardous to property or dangerous to any person. The Fire Marshal or designee may, in the exercise of reasonable discretion, approve or disapprove the display site, and/or may impose reasonable conditions on the display.
